Immediately prior to the disposal of shares in the Company:

- (a) Stephen Roland Dattels had the power to control 100,000 ordinary shares in the Company which were owned by Osivis Private Capital Limited and held on trust for Stephen Roland Dattels; and
- (b) Stephen Roland Dattels was an associate of Polo Resources Limited (**Polo**) by virtue of section 12(2)(c) of the Corporations Act.

Stephen Roland Dattels was originally disclosed as a substantial holder of shares in the Company in the Form 603 dated 22 July 2009 that was lodged by Polo with the Company both for itself and on behalf of its associates.
